The 'landed cost' is what every buyer/importer needs to know in order to make a solid purchase decision.

Audit

Our policy is that, before you invest your hard earned money into production with a new factory, we must visit and audit the supplier.

This stage is crucial as, often during this audit, we can at the same time build relations with key staff, and potentially negotiate prices and terms even further.



Our contracts with Chinese vendors are legally binding in mainland China.

Having a clear & legal contract that defines payment terms, quality standards, lead times and relevent penalties is essential to manage your intresrests once goods are in production.

Quality Control should be at the top of any importer's priorty list. Generally, most importers will have us do one PSI (pre-shippment Inspection) after production has finished but before the goods are shipped. We do also provide mid-production checks, and container load checks.

Payment Terms & Credit

Generally, Easy Imex payment terms will be 30% deposit and 70% against bill of lading (once goods have been shipped) however, we are also able to offer improved navment terms

These can be as good as 0% deposit and payment 90 days after goods have been exported. (subject to credit checks and trading history).



Logistics

Only when goods have passed quality control, or with your permission, will we ship the goods. We have contracts with some of the worlds largest shipping lines.

Due to the volume we export collectively as a business, we are able to provide our customers with preferencal freight / import charges. This is passed on to you at cost price with no extra fees from us.

SERVICE TERMS & CONDITIONS



Terminology

Sourcing Request: Covers one product for the complete Product to Market sourcing process that addresses one Stock Keeping Unit (SKU).

Stock Keeping Unit (SKU): A unique type of product which can include changes in colour, design, size etc.

Inspection Unit: Covers one inspection that can be either be factory audit/visit or Quality Control inspection.

Landed Cost: The total cost of your order, delivered to your door.

Basic Package

Inspection Unit:

Service charge of \$250 USD plus any travel expenses (e.g. transportation and accommodation) should be paid by the customer.

Additional Sourcing Requests:

If more than 10 sourcing requests are needed per year, clients can add 5 new sourcing requests at a charge of \$150 USD in total. Clients can repeat orders with products that have been previously sourced with Easy Imex without using a new sourcing request.

Membership Expiration:

Client membership remains active as long as the client orders a minimum of \$20,000 USD per year. If the order value does not reach this amount, then the membership will expire.

Sourcing Report:

The final sourcing report includes a total of 5 manufacturers. However, the number of manufacturers may vary according to the manufacturer scarcity of the requested product.

Package Upgrade:

If the client requests to upgrade the service to Premium, the full Premium Package fee will be charged.

Premium Package

Free Inspections:

The client can use up to 4 free inspection units per order. Each order should amount to a total value of \$20,000 USD (or container load) for 4 free inspection units to be allocated. After the 3rd order, Easy Imex will not place any limits on free inspection units, on the basis that the client becomes a regular importer. Each inspection unit comes with a travel cost paid for by the client (excluding the "Pre-Shipment Inspection" which has no travel expenses and is limited to 1 per order)

Credit Facility:

Eligible for a credit check once signed up to our services. Credit check is based on the following factors: 2 years or more in business, and successfully completed \$50,000 USD worth of orders with Easy Imex on standard payment terms of 30% deposit, and 70% paid against the bill of lading. The credit insurer runs a check on the customer's business and provides Easy Imex a credit limit. (for more information please ask us for our Credit Facility Brochure) Membership Expiration: Client membership remains active as long as the client orders a minimum of \$20,000 USD per year. If the order value does not reach this amount, then the membership will expire after 12 months.

Sourcing Report:

The final sourcing report includes a total of 5 manufacturers. However, the number of manufacturers may vary according to the manufacturer scarcity of the requested product.

Unlimited Sourcing:

Unlimited product sourcing only applies if the client orders at least \$20,000 USD worth of goods per year. If this amount has not been reached, then the Sourcing Requests availability will be capped at 20 SKUs.

Product Photos:

A total of 5 professional white background photographs per SKU and edited on photoshop (angles include front, back, right side, left side and dimensions). Marketing photos are free of charge for up to 10 SKUs. Additional photos can only be offered after the minimum total order value reaches \$20,000 USD or at a fee quoted on a case by case basis.

Product Development Package

Extra Costs:

If any molding/tooling is needed, this should be paid for by the customer. The extra costs that may arise, are listed in the "Product Development Proposal". The costs all relate to developing the specified product.

Sourcing Report:

The final sourcing report includes a total of 5 manufacturers. However, the number of manufacturers may vary according to the manufacturer scarcity of the requested product.

Termination of Monthly Fee:

The monthly fee stops when the final sample has been confirmed by the client and is ready for mass production. The customer can stop the product development process at any moment whereby the monthly payment will stop immediately. When the client completes the product development phase and the product is ready for mass production, the client will have the same benefits as in the Premium Package.

Credit Facility:

Eligible for a credit check once signed up to our services. Credit check is based on the following factors: 2 years or more in business, and successfully completed \$50,000 USD worth of orders with us on standard payment terms of 30% deposit, and 70% paid against the bill of lading. The credit insurer runs a check on the customer's business and provides Easy Imex a credit limit.
